INSTRUCTIONS

This is a summons to appear in the Municipal Court at the City of Lufkin, 300 E Shepherd Ave, Lufkin, Texas, under 543.003 of the Texas Transportation Code. Your failure to appear in court as provided by law for the prosecution of the offense or if you fail to pay or satisfy a judgment ordering the payment of a fine and cost in a manner ordered by the court, may subject you to issuance of a warrant for arrest and a fine up to \$500.00 and you may be denied renewal of your driver’s license and vehicle registration and accessed additional fees.

By law, a telephone call does not meet the requirements for answering to the charge. No appointment dates will be assigned by phone. Your signature is required to receive an appointment date.

IF YOU ARE UNDER 17 YEARS OF AGE you cannot pre-pay the fine by mail or in person. State law requires that you must appear before the Judge. You must appear at the Court to make an appointment to see the Judge and must appear with a parent or legal guardian.

ANSWERING YOUR CHARGE BY MAIL: To pay by mail, send a check, cashier’s check or money order with the full amount due within 12 days of receiving the citation to Lufkin Municipal Court, PO Box 190, Lufkin, Tx 75902. Write your ticket number on your money order.

DEFENSIVE DRIVING: If you have not had a Driving Safety Course in the preceding 12 month period and have a valid Texas Driver License, you may qualify to take the class to dismiss one violation on your ticket. You must provide written notice to the Court on or before your appearance date of your desire to do so, provide a plea of Guilty or No Contest, and proof of insurance or financial responsibility, and a **\$107.10 (Non-School Zone) or \$132.10 (School Zone) state fee due at the Court within 12 days of the citation date.** You have 90 days from the citation date to complete a Texas approved Driving Safety Course and return the Certificate of Completion to the Court. You can not take a Driving Safety Course for the following violations: Passing a School Bus; Speeding 25 miles or more over the speed limit; Reckless Driving; Leaving the Scene of an Accident, Fail to Stop and Give Information/Render Aid; any offense committed in a Construction Zone with men working; any violation if you have a Commercial Driver License.

If you wish to plea Not Guilty, sign below for a Pre-trial Docket appointment and return this form to the Court within 12 days of the citation date. Your docket setting will be mailed to you (please verify that the address on the front of the ticket is correct).
